# Report to the Members

## On Governance

### PWPA Supports Tatak Pinoy Act and Industrialization Initiatives

The **Philippine Wood Producers Association (PWPA)** represented by Executive Director Maila Vasquez attended a public hearing of the Senate Committee on Finance on July 6, 2023. The hearing focused on Senate Bill No. 2218 (Tatak Pinoy Act) and Resolution No. 4, which inquired into the government's industrialization and employment generation initiatives.

During the deliberation, Executive Director Vasquez shared their recommendation on the inclusion of the Department of Environment and Natural Resources (DENR) in the National Infrastructure Development Strategy and the Tatak Pinoy Council. As the agency regulating the industry's raw materials, the DENR needs to be on top of what is happening to ensure the availability of the resources. She emphasized the importance of sustainable management of raw materials to ensure continuous production of high-quality local products.

Senate Committee Chair, Senator Sonny Angara expressed his appreciation for PWPA's position and indicated his intention to consider the inclusion of the DENR in the Bill.

The PWPA's participation in the Senate hearing demonstrates its commitment to promoting local industries and supporting government initiatives for economic development. By advocating for the inclusion of the DENR, the PWPA aims to ensure that sustainable forest management practices are integrated into the country's industrialization efforts.

### PWPA Supports Tree Growing Act Bill at Congress Committee Hearing

The Public Hearing on the Tree Growing Act (TGA) Bill was held on November 29, 2023, at the Batasan Complex in Quezon City. The hearing was chaired by Honorable Alfonso V. Umali, Jr., Vice Chairperson of the committee.

The Foundation for Economic Freedom's Ms. Angela Arnante presented a briefing on the TGA Bill.

Congressman Joey Salceda emphasized the importance and benefits of the proposed legislation.



Various resource persons from government, non-government, and private sectors shared their positions on the Bill. The Philippine Wood Producers Association, Inc. represented by PWPA Trustee Evaristo Narvaez, Jr. and Executive Director Maila Vasquez attended the hearing.

PWPA Trustee Narvaez, Jr. shared his experiences with PICOP and highlighted the potential of the Bill to provide a legal framework for tree growing/farming/ plantations. The Forest Management Bureau mentioned that the DENR is reviewing Executive Order No. 23 of 2011, which they consider a contributing factor to challenges in the sector.

Other agencies that provided their positions included DENR Region 4A, DTI-Bureau of Investment, Haribon Foundation, National Commission on Indigenous People, and the Bureau of Internal Revenue.

Overall, the hearing provided a platform for various stakeholders to discuss and share their perspectives on the Tree Growing Act Bill and its potential impact on the forestry sector. PWPA's involvement demonstrates its commitment to supporting initiatives that promote sustainable forest management and contribute to the country's economic development.

## On International Events

### PWPA Participation in Asia Grey Timber Analysis Workshop

The Philippine Wood Producers Association (PWPA) attended the Asia Grey Timber Analysis (AGTA) Workshop, organized by the USAID Integrated Natural Resource Management (INRM) Asia Grey Timber Initiative, last May 11, 2023 in Singapore. The workshop aimed to develop solutions to reduce the volume and value of illegal timber and wood products in the supply chains of the Asia-Pacific region.



The workshop focused on analyzing the results of the AGTA study, which quantified the trade in grey timber in forest commodity chains. Participants worked together to identify effective solutions for increasing transparency and traceability in interregional supply chains.

Representatives from Singapore, Malaysia, Indonesia, and the Philippines participated in the workshop with the Society of Filipino Foresters, Inc. (SFFI) President Roberto Oliva and the PWPA Executive Director Maila Vasquez representing the Philippines.

The workshop featured interactive sessions, including breakout groups where participants discussed and shared ideas on potential solutions.

The workshop focused on two key areas:

- Integrated Solutions by addressing issues such as forest governance, supply chain tightening, law enforcement, and data exchange.
- Specific Solutions by exploring options like civil society monitoring, mill-level due diligence, customs risk management, and online registries of illegalities.

PWPA made its own observations and sentiments which includes the Philippines' transition from producer to importer and the need for improved certification and law enforcement.

The PWPA's participation in the Asia Grey Timber Analysis Workshop demonstrates its commitment to addressing the challenges of illegal timber trade in the region. Its contribution to the development of effective solutions can help promote sustainable forest management and protect the integrity of the wood industry.

### PWPA Participates in PFEN's 1<sup>st</sup> International Conference

The Philippine Wood Producers Association (PWPA) attended the 1st International Conference of the Philippine Forestry Education Network (PFEN) on October 25-27, 2023, in Davao City. The conference theme, "Engaging the Academe in the Revitalization of the Wood and Wood-based Industries for Economic Recovery," brought together representatives from over 50 universities offering BS Forestry courses.

DENR Secretary Ma. Antonia Yulo-Loyzaga was scheduled to deliver the keynote address but was unable to attend due to other commitments. She was represented by DENR Assistant Secretary Ruth Tawantawan who provided an update on the state of the art in wood and wood-based industry.

PWPA Trustee E.M. Narvaez, Jr. presented a paper titled "Status of the Wood Industry and Role in the Revitalization of Wood and Wood-based Industries: Ways Forward."

As an international perspective, Dr. Rico M. Gazal from Glenville State University shared the university's experience in generating linkages with the wood industry.

During the plenary session the focus of discussion was the improvement of linkages between industry and academia, as well as global trends in afforestation, reforestation, and revegetation. Experiences and recommendations were also shared on the presentations on watershed development, tree plantation development, and the status of the wood industry.

The conference concluded with a welcome and fellowship dinner and a presentation of posters and papers related to the conference theme.

The PWPA's participation in the PFEN conference provided an opportunity to engage with academic institutions and industry stakeholders to discuss the challenges and opportunities facing the wood and wood-based industries. By sharing insights and experiences, the PWPA contributed to the ongoing efforts to revitalize the sector and promote sustainable forest management.

## PWPA Participates in RP-Russian Online Business Missions

The Philippine Wood Producers Association (PWPA) actively participated in two online business missions organized by the Trade Commission of the Russian Federation. These missions aimed to foster trade relations and explore opportunities for collaboration between the two countries.

Due to short notice, only five PWPA member companies attended the mission on August 23, 2023. The participating companies, Red October, Perm-House Building Company, Silver Trade LTD, Black Horse Group, and Coal Trading Company, showcased a diverse range of products, including sawn timber, veneer, plywood, pellets, brickets, and firewood.

On September 18, 2023, eleven PWPA member companies participated, with eight Russian companies presenting their wood and wood products. They showcased a variety of wood products, including sawn timber, veneer, plywood, pellets, brickets, and firewood.

The PWPA identified logistical concerns as one of the challenges in having trade relations, they invited the Keystone Logistics to attend the mission. They made a presentation and highlighted their freight forwarding services to address said logistical challenges.

Russian Trade Commissioner: Mr. Artem Tsinamdzgvrishvili, Trade Commissioner of Russia in the Philippines, emphasized the growing interest in cooperation with the Philippines and expressed hope for positive outcomes from the missions.

The missions provided opportunities for PWPA members to connect with Russian businesses and explore potential partnerships in the wood and wood products industry.

## The Association and Members

### PWPA Attends FEF Eduk-Aksyon Lecture Series on Education

Philippine Wood Producers Association (PWPA) Executive Director Maila Vasquez joined the **5th Paderanga-Varela Memorial Lecture** which focused on the challenges and potential solutions to the education crisis in the Philippines. The event was held on April 26, 2023, at the Family Hall, Ascott, Glorietta 4, Makati City.



The highlights of the lecture series are as follows:

Foundation for Economic Freedom (FEF) President Calixto Chikiamco welcomed attendees and sponsors, providing the rationale for the lecture series. It was followed by a video message of Vice President and Education Secretary Sarah Duterte expressing her gratitude to FEF for organizing the event and emphasized the need for private sector support in addressing education concerns.

Senator Sherwin Gatchalian gave the keynote message and acknowledged the importance of the lecture series. He also discussed the challenges faced by the education sector and highlights the need for solutions to make it a competitive sector.

Dr. Vicente Paqueo, Dr. Aniceto Orbeta, and Dr. Victor Limlingan made a presentation on the DepEd's Voucher Program, Assessment of Junior High School Education Service Contracting, and Alternative Service Delivery Systems, respectively with Dr. Michael Alba, House Rep. Stella Luz Quimbo, and Mr. Alfredo Ayala sharing their insights and recommendations on improving the voucher system, service contracting, and service delivery.

The discussions highlighted the need for a comprehensive approach to addressing the education crisis, including upgrading education standards, considering values and culture, promoting public-private complementarity, and exploring the potential of artificial intelligence.

Overall, the lecture series provided a valuable platform for discussing the challenges and opportunities in the Philippine education sector and generated insights for potential solutions.

## PWPA Attends Seminar on Import Surge Monitoring and Trade-Related Matters

The Philippine Wood Producers Association (PWPA) participated in a seminar organized by the DTI Bureau of Import Services (BIS) on Import Surge Monitoring held on May 31, 2023, at the Diamond Hotel in Makati City. The seminar was organized by the DTI Bureau of Import Services (BIS) and aimed to introduce the BIS Import Surge Monitoring System and discuss trade-related topics.

The seminar unveiled the new monitoring system, which allows stakeholders to track the volume of imported goods. BIS Director Maria Guiza Lim made a short overview of what the BIS Import Surge Monitoring System is all about and said that it is still work in progress and they will welcome the comments and suggestions of their stakeholders.

DTI Assistant Secretary Allan Gepty discussed the Philippines' involvement in free trade agreements and emphasized the importance of maximizing their benefits. BIS Ms. Eulayra Valones discussed Philippine Trade Remedy measures, including anti-dumping, countervailing, and safeguarding.



DTI Undersecretary Ceferino Rodolfo highlighted the significance of the BIS Import Surge Monitoring System in assisting clients and stakeholders in their international trade relationships.



The seminar also discussed the challenges and opportunities associated with international trade agreements and the need for continuous improvement in the monitoring system.



DTI BIS Assistant Director Armando Mercado, Jr. said that they will be waiting for the requested reports which they will provide and also appreciate getting suggestions and recommendations on how they can further improve the system so they can serve their clientele better.

The PWPA's participation in the seminar demonstrates its commitment to supporting the Philippine trade industry and promoting fair and competitive practices.

# Report to the Members

## PWPA-SFFI Meeting: Collaborating on Forestry Sector Revitalization

The Philippine Wood Producers Association (PWPA) met with the Society of Filipino Foresters, Inc. (SFFI) President Roberto Oliva to discuss strategies for revitalizing the forestry sector. The meeting, held on July 17, 2023, focused on the impact of Executive Order No. 23 of 2011 and the need for legal clarity regarding the suspension of the Integrated Forest Management Agreement (IFMA).

The PWPA and SFFI agreed on the importance of reviewing Executive Order No. 23 to assess its impact on the forestry sector and the wood industry.



The meeting emphasized the need for legal clarity regarding the suspension of the IFMA, which was deemed a violation due to its unilateral nature. SFFI President Roberto Oliva discussed the organization's ongoing efforts to support the wood industry and revitalize the sector. He shared its draft executive order on tree revolution, which aims to remove restrictions on tree plantation development and management.

PWPA suggested including an inventory of natural forests in the executive order to provide a clearer understanding of the country's forestry resources.

The PWPA was represented by Trustees Antonio Olizon and Evaristo Narvaez, Jr. and Executive Director Maila Vasquez.

The meeting between PWPA and SFFI highlighted the importance of collaboration between industry stakeholders and professional organizations in

addressing the challenges facing the forestry sector. By working together, these organizations can contribute to the development of effective policies and strategies for the revitalization of the wood industry.

## PWPA to Participate in SFFI's 75<sup>th</sup> Annual National Conference

The Philippine Wood Producers Association (PWPA) is set to participate in the 75th Annual National Conference of the Society of Filipino Foresters, Inc. (SFFI), scheduled for November 8-11, 2023 in Subic, Olongapo City.

The conference theme, "SFFI@75: Advocating Wood and Non-Timber Forest Products Sufficiency for Climate Resiliency," aims to address key challenges and opportunities facing the forestry sector. The conference will feature three plenary sessions focusing on:

1. **Self-Sufficiency in Wood and NTFP:** Exploring strategies to achieve self-sufficiency in wood and non-timber forest products.
2. **International Partnerships:** Fostering collaboration with international forestry professionals.
3. **Rekindling Professional Pride:** Strengthening the forestry profession and promoting pride among its members.

The PWPA has been invited to participate as a discussant in the first plenary session, focusing on the topic of "Revitalizing the wood industry through tree plantation." The association will share its insights and experiences on the potential of tree plantations to contribute to the economic growth of the country.

The SFFI Executive Committee and host regional chapter have been actively preparing for the conference. They have finalized the conference theme and identified key speakers for the plenary sessions. The PWPA will be sending a formal letter to confirm its participation and discuss specific topics for discussion.

The PWPA's participation in the SFFI's 75<sup>th</sup> Annual National Conference underscores its commitment to the forestry sector and its role in promoting sustainable development and economic growth. The conference provides an important platform for stakeholders to discuss pressing issues and explore potential solutions for the future of the forestry industry in the Philippines.

## PWPA Participation in Carbon Forestry Forum

The Forest Carbon Forum organized by the UPLB College of Forestry and Natural Resources (CFNR) Forestry Development Center (FDC) co-organized with the Department of Environment and Natural Resources (DENR) Forest Management Bureau (FMB), Kennemer, United States Agency for International Development (USAID), and Klima 1.5 Corp. aimed to discuss challenges and opportunities for sustainable nature-based climate solutions through forest carbon projects in the Philippines.

DENR Secretary Ma. Antonia Yulo-Loyzaga delivered the keynote message via Zoom followed by a refresher presentation of Dr. Juan Pulhin on the 6th Assessment Report of the Intergovernmental Panel on Climate Change (IPCC). Dr. Dennis Garrity discussed the golden pursuit in nature-based solution and climate change mitigation.

Forester Lawyer Tomas Kabigting presented the guidelines on the Carbon Accounting, Verification, and Certification System (CAVCS) for forest carbon projects, emphasizing that the system is still under development.

Several groups shared their experiences and insights on implementing forest carbon projects.

Forester Antonio Contreras raised a question about the focus on protection forests in forest carbon applications and the potential benefits of including production forests and Dr. Garrity clarified that forest carbon projects can include both protection and production forests, and that harvesting can play a significant role in carbon sequestration.



The forum provided a valuable platform for discussing the potential of forest carbon projects in addressing climate change in the Philippines. However, the absence of higher-level DENR officials may have limited the direct impact of the discussions on policy development.

## PWPA Attendance at the SFFI's 75<sup>th</sup> National Conference

The Philippine Wood Producers Association (PWPA) participated in the 75<sup>th</sup> National Conference of the Society of Filipino Foresters, Inc. (SFFI), held in Subic, Olongapo City from November 8-11, 2023. The conference theme, "SFFI@75: Advocating Wood and Non-Timber Forest Products Sufficiency for Climate Resiliency," brought together over 2,000 foresters from across the country.



DENR Assistant Secretary Arleigh Adorable delivered the keynote address, representing Secretary Ma. Antonia Yulo-Loyzaga.

The conference included the SFFI General Membership Assembly, where members discussed annual accomplishments, financial status, and launched the SFFI Welfare Fund.

There were three plenary sessions which focused on:

- The Need for Forestry Sector Contribution to the National Economy: Presented by DENR Undersecretary Jonas R. Leones and discussed by experts from various organizations.
- Forging Partnerships with International Forestry Professionals: Introduced by UPLB CFNR Professor Emeritus Dr. Rex Victor O. Cruz and featuring international speakers.
- Rekindling Pride in the Forestry Profession: Introduced by DENR Region 5 Regional Executive Director Francisco E. Milla, Jr. and discussed by forestry professionals.

Representatives from Malaysia, Lao PDR, SFFNA, and SFFI signed a Memorandum of Understanding to continue their partnership for forestry profession development.

The SFFI's 75th Annual National Conference provided a valuable platform for forestry professionals to discuss pressing issues, share experiences, and explore opportunities for collaboration and advancement in the field.

## On Product Monitoring and Certification

### PWPA Attends FPI Meeting on Mandatory Certification Enforcement

The Federation of Philippine Industries (FPI) held a meeting on April 28, 2023, to discuss the implementation, enforcement, and prosecution of violators of mandatory standards. FPI Chairman Jesus Arranza called the meeting in preparation to the FPI scheduled meeting with the DTI Secretary to launch an aggressive campaign on mandatory standards enforcement.

Representatives from various industries, including angle bar, battery, glass, and plywood manufacturers, attended the meeting to share their experiences with implementing mandatory standards. The Philippine Wood Producers Association, Inc. attended the plywood manufacturers.



FPI Dr. Ernesto Ordonez, chair of the committee on product standards, announced changes in the monitoring process for hardware and stores carrying products under mandatory certification. He said that a manufacturer-based monitoring will be the new approach where they will rely on reports submitted by manufacturers who will purchase and test their products. Based on the results, the FPI will schedule store monitoring and invite manufacturers to participate optionally.

Dr. Ordonez expressed hope for industry support in the new monitoring scheme.

The meeting emphasized the importance of strict enforcement of mandatory certification standards to ensure product quality and consumer safety. The new monitoring scheme aims to enhance efficiency and effectiveness while encouraging greater industry participation.

## PWPA Participation in PFCS Interim National Governing Body Meeting

The Philippine Forest Certification System (PFCS) Interim National Governing Board (INGB) held a meeting on July 12, 2023 to discuss the progress and future of the PFCS.



The meeting was attended by representatives from the Society of Filipino Foresters, Inc. (SFFI), Department of Environment and Natural Resources (DENR) Forest Management Bureau (FMB), National Commission on Indigenous Peoples (NCIP), Philippine Center for Environmental Protection and Sustainable Development, Inc. (PCEPSDI), Philippine Wood Producers Association, Inc. (PWPA), and UPLB Forestry Development Center (UPLB FDC).

The meeting was chaired by SFFI President Roberto Oliva who welcomed the participants in the meeting.

# Report to the Members

PCEPSDI Executive Director (ED) June Alvarez, as the secretariat of the PFCS, provided a refresher on the accomplishments of the Board before its inactivity due to the pandemic and shared efforts to establish the PFCS.

PWPA ED Maila Vasquez updated the Board on the status of the Chain of Custody (CoC) and Sustainable Forest Management (SFM) for Plantation standards, which are awaiting issuance as Philippine National Standards (PNS).

The Board discussed the importance of establishing the PFCS system, especially in the light of increasing interest in carbon credits.

SFFI President Roberto Oliva emphasized the need to include the production aspect of the forest alongside carbon credits to ensure sustainable wood supply.

PWPA ED Vasquez highlighted the challenges of implementing the PFCS without certified raw materials and the need for reciprocity in international trade.

DENR FMB representatives expressed their commitment to support the PFCS and shared their ongoing project on Biodiversity Corridor, which may require a similar certification system.

The meeting reaffirmed the importance of establishing the PFCS and discussed the necessary steps to move forward, including addressing challenges related to raw material certification and alignment with other initiatives.

On August 14, 2023, another meeting of the PFCS INGB was held and the discussion focused on the progress of the PFCS and discussed strategies for its implementation.



DENR Assistant Secretary and FMB Director Arleigh Adorable chaired the meeting in the absence of Chair, SFFI President Roberto Oliva.

Representatives from SFFI, DENR-FMB, PCEPSDI, PWPA, and UPLB FDC attended the meeting.

PCEPSDI ED Alvarez and PWPA ED Vasquez provided a refresher on the Board's accomplishments before its inactivity due to the pandemic and shared efforts to establish the PFCS and update on the status of the CoC and SFM for Plantation standards, which are awaiting issuance as PNS respectively.

Forester Gab Calderon presented the DENR FMB's Biodiversity Corridor project and the draft DAO on establishing the PFCS. As one of the component of their project, they want to pilot the standards to their project site.

The meeting resulted in agreements on the following actions:

- Technical Committee on 78 will endorse the Draft PNS on CoC and SFM for Plantation.
- The Biodiversity Corridor project will be used to pilot test the issued PNS.
- The Board will seek support from the Department of Trade and Industry for the endorsement of the Executive Order on PFCS.
- Implementation procedures for PFCS will be developed.
- Capacity building of stakeholders will be conducted through the Biodiversity Corridor project.

The meeting provided a valuable platform for stakeholders to discuss the progress and challenges of the PFCS. This demonstrates the Board's commitment to supporting sustainable forestry practices and promoting the development of a robust certification system in the Philippines.



## PWPA Joins FPI Meeting on Product Monitoring

The Federation of Philippine Industries, Inc. (FPI) held a meeting on December 8, 2023, via Zoom, to discuss product monitoring.

# Report to the Members

FPI Director Ernesto Ordonez called the meeting to address product monitoring concerns and discuss strategies for immediate action. He mentioned that with the appointment of the new DTI Secretary, he has requested their assistance in providing immediate action and monitoring for industry leads within 48 hours.

He discussed the process for the monitoring which involves industries to purchase products in stores and check whether they are compliant with standards, such as marking and labeling in plywood. He added that the FPI will provide templates for easy reporting.

Various industry associations and product manufacturers attended the meeting, including representatives from wood, steel, cement, and other sectors. The wood industry was represented by Philippine Wood Producers Association, Inc. The participating industries expressed their willingness to cooperate and submit reports on product monitoring.

The meeting aimed to establish a more efficient system for product monitoring and ensure that products comply with relevant standards within the Philippine manufacturing industry.
